COMES NOW the undersigned attorney, Otavio Haverroth Silva, in the capacity of counsel for the above-identified Respondent, and respectfully submits the following Supplemental Answer in response to the Court's Finding of Removability and Scheduling Order issued by the Honorable Immigration Judge Michelle Slayton on January 18, 2026.

In the referred Order, the Court determined that, within a period of sixty (60) days, the Respondent shall file any and all applications for relief not yet filed, accompanied by prima facie evidence of eligibility, together with specific additional information as set forth in the Order.

A Form I-589, Application for Asylum and for Withholding of Removal, was filed, along with prima facie evidence of the Respondent's eligibility for asylum, withholding of removal, and protection under the Convention Against Torture, in strict compliance with the deadlines and guidelines established in the Scheduling Order and by this Honorable Court.

In compliance with the Court’s Scheduling Order, the Respondent provides the following information:

1. The Respondent estimates that the Individual Hearing will require approximately 3 (three) hours;
2. Respondents and counsel’s preferred format of attendance is **internet-based**, to avoid the logistical challenges and expenses associated with travel;

3. The Respondent's native language is **Salvadoran Spanish**. She respectfully requests the assistance of a Spanish interpreter with the national variant Salvadoran Spanish, for all future hearings;

In light of the foregoing, the Respondent respectfully requests that this Honorable Court accept the information and documents herein submitted and that all requests herein be fully granted.
