Streets through which I walked to get home every day.



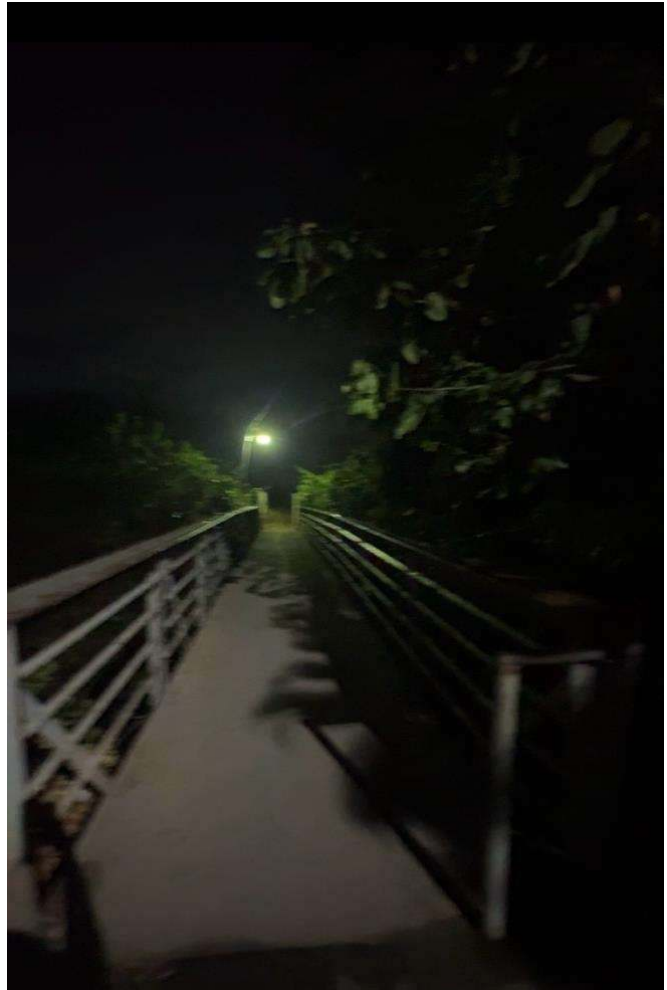
