RESPONDENTS' MOTION TO CORRECT CASE INFORMATION

COMES NOW, Natalia Vieira Santanna, counsel for the above-referenced Respondents, and respectfully requests the correction of case information as it relates to the name of the minor Respondent. In support of this motion, Respondents submit the following:

1. Respondents are currently in removal proceedings before this Honorable Court. Their cases move together as a family unit.
2. The Notice to Appear (Form I-862) for minor Respondent Jostin Alexander Velasquez-Chavez, A245-308-584, issued October 3, 2023, lists his first name as "JUSTIN."
3. However, the minor Respondent's correct legal name is "Jostin Alexander Velasquez-Chavez," and the spelling "Justin" is incorrect. His correct legal name is "JOSTIN" as shown in the supporting identity documents.

4. Respondents submit documentation confirming the correct spelling of the minor Respondent's name, including the minor Respondent's birth certificate (See Exhibit 01) and passport (See Exhibit 02).
5. This appears to be a clerical/spelling error that may cause confusion, mismatched records, or processing delays in this matter.
6. To avoid inconsistencies and ensure accurate Court records going forward, it is necessary to correct the spelling of the minor Respondent's first name in the case file and in any associated entries, notices, and future communications.

WHEREFORE, Respondents respectfully request that this Honorable Court grant this Motion and amend the caption and Court records—including any electronic entries and future notices—to reflect the correct spelling of the minor Respondent's name for A245-308-584 as:

JOSTIN ALEXANDER VELASQUEZ-CHAVEZ (not "JUSTIN").

Because the cases of all three Respondents move together as a family unit, Respondents further request that the correction be reflected across the family-unit case record to avoid mismatched notices.


